D. City Manager's Comments (Given by Asst. City Manager Jackson)

- Looking at chip sealing about twenty-nine blocks this year.
- The Brick and Tile playground is being constructed. Weather has slowed down the progress.
- Poured the floor for the bathroom for the Brick and Tile Park. Will start building walls in twenty-eight days.
- Should receive the Army Corps of Engineers 404 permit, in order to start the bidding process for the trail, in the next couple of weeks.
- The EPA is going to start testing for PFAS. We are working with our engineers on this.
- We have 200 kids signed up for soccer. There were only thirteen kids in the 7th-8th grade, so we don't have enough kids for that age group.
- Have ordered the scoreboard for Veteran's Field. It won't be delivered until the end of July.
- The Senior Center is having an open house on April 21st from 1:00-3:00 p.m., showcasing their services.

Asst. City Manager Jackson: The budget was approved as presented. Now staff is operating on a 24% reduction in the general fund. We need to solidify that and explore other options for individual departments.

DISCUSSION: The Ark Valley Conduit and pending utility rate increases have no impact on the General Fund, these are Enterprise Funds. The original budget was already approved. The internal changes for the 24% cuts need to be approved as an amendment to the budget. It is up to the Council to approve what each department in the general fund was able to cut.

ORDINANCE NO. 1644

AN ORDINANCE OF THE CITY OF LA JUNTA AMENDING TITLE 17 OF THE MUNICIPAL CODE

WHEREAS, the City has adopted various provisions with Title 17 for use within the City; and

WHEREAS, the City desires to update its code;

WHEREAS, the City received from the Department of Local Affairs ("DOLA") a Rural Economic Development Incentive (REDI) Grant to assist with economic development and the creation of affordable workforce housing for the community; and

WHEREAS, the update of the City's zoning code includes DOLA's qualified strategies for the creation of affordable housing including the expedited review of housing projects throughout the City, allowing for mixed use in the downtown commercial core, and allowing for additional housing types including multifamily, ADUs, and townhomes to create housing mobility for the City's workforce and aging population;

WHEREAS, the update of the City's zoning code allows for compliance with the State wide ballot initiative Prop 123 by expediting the City's ability to create additional affordable housing units over the next 3 years;

WHEREAS, the City desires to support the business community by allowing flexibility and adding new commercial uses that diversify and increase employment opportunities for its residents in its commercial and industrial zones;

NOW, THEREFORE, BE IT ORDAINED by the City Council as follows:

- SECTION 1. Title 17 of the Municipal Code is repealed in its entirety.
- SECTION 2. A new Title 17, attached hereto as "Exhibit A" is enacted in its entirety.
- SECTION 3. EFFECTIVE DATE: The effective date of this Ordinance shall be effective May 1, 2023

SECTION 4. Consistent with provisions of the City Home Rule Charter, this ordinance and the provisions thereof shall be published by title only.

SECTION 5. A copy of the ordinance shall be available at the City Engineer's office for citizen review upon request.
