## CITIZEN PARTICIPATION FOR NON-AGENDA ITEMS (5-minute time limit per person):

- 1. <u>Douglas Golding, 1316 Lincoln Avenue:</u> Congratulations to the newly elected and re-elected members of the council. I wasn't in favor of 2A but I see the necessity for it passing. I don't think I'm alone. I don't think a lot of people voted for a tax increase, they voted to avert having things closed. I hope with the passage of 2A, our city leaders don't see this as a mandate for business as usual. In the last two years, under current leadership, the city financials have become worse, which necessitated the passage of the sales tax increase. If our leaders continue, as in the past, we will again face the same problem in the future. I hope our leaders understand and are more financially prudent in their spending in the future. I also hope our leaders refrain from using falsehoods in justifying their actions. I ask the re-elected mayor and this council to do the job they are elected to do and hold the line on frivolous spending and say no to push personal pet projects. We also need to call on our citizens to take responsibility for their properties.
- 2. <u>Daxton and Drew Stokes (Talor Hall), 16 E. 22<sup>nd</sup> Street</u>: Requested a street closure on Saturday December 2<sup>nd</sup> in conjunction with the Parade of Lights for a small holiday event. They will serve hot dogs and will be roasting smores as a fundraiser for the CSP Toy Drive.
- 3. Kimberly Gallegos, Woodruff Memorial Library: Myself and everybody behind me, we don't think that 2A only passed because people wanted to save places, it was about the future. (The following letter was read and submitted): "On behalf of Woodruff Memorial Library, we extend our sincere gratitude to every person who showed their support during the election. The goal for us was to educate the community about how your local sales tax dollars go to the General Fund and make it possible for 22 City of La Junta departments to serve our community. It took a "village", and ALL TOGETHER, WE DID IT!! Our efforts were always about the future of La Junta. The opportunity to see an ocean of people come together with a common goal to explain to people the importance of their investment, was incredible! A huge shoutout to the "2A 4 LJ Committee" who were a group of people from all walks of life, some who could vote on 2A and some who could not, who made a decision at some

point to spend time, energy and money on fighting for what is best for our city. Even if you were not a part of this committee, the time you spent keeping the discussion going on the importance of sales tax made a world of difference. How amazing it feels to be a part of a community that cares! We desire to serve our community to the best of our ability providing a plethora of resources, some that can only be found at Woodruff Memorial Library. In Memory of Connie and George here is an article of the importance they played in the history of Woodruff Memorial Library and founding Woodruff Memorial Library Friends.

#### Giving back to the community

Woodruff Library Friends George and Connie Elder were honored Friday as a conclusion to library week as part of the 120<sup>th</sup> celebration.

Connie moved to La Junta in 1963, George was born here. In the early 1990s Sandra Hockmeyer was the librarian and she, with several others, approached the Elders with a great vision of having a group of people, aside from the city of La Junta, who would be known as "Friends of the Library" and would help in the interest of the library. By May of 1995 the Friends of the Library were incorporated and the first book sale was held in 1996.

George and Connie Elder have been dedicated to the library without fail from the beginning of the Friends. When asked why they have been so dedicated to the library the answer easily came. "Because we believe in it." They both also added that it is "A way to give back to the community." They plan to stay active with the library "until we can't move."

In the 14 years that the Elders have been highly involved with the Friends of the Library they have seen great technological progressions. They were there when everything was done by hand, have seen computers come in, and the use of databases, just to name a few.

When asked what their favorite part of the library is they struggled to narrow their answer down to just a couple. Both Elders decided that for fun reading they like mysteries. But both agree that they like to read just about anything.

Connie feels that getting the new library was their biggest accomplishment while George thinks getting book sales done was his biggest accomplishment during their time at the library. But when asked if there was anything they have not been able to accomplish as a Friend of the Library George stated that new needs are discovered continually. It is impossible to say one specific thing.

They feel that as technology grows and needs change there will be changes in the Friends' and library's futures.

Current Woodruff Memorial Librarian Sandy Messick reported meeting George and Connie in the summer of 1979 and has shared many personal experiences over the years. Messick reports that they have provided much support for her as well as others and have worked very hard at fundraising. "They've only been a call away."

La Junta City Manager Rick Klein said that communities are made up of individuals. Some of those individuals step up. He said, "They (The Elders) gave me courage to do

my job." Klein also feels that a plaque does no justice for the work they've done. In receiving the award Connie said, "it's been a pleasure serving the community. We appreciate the plaque, but couldn't have done it alone. We appreciate the help over the years." And George sums up with "It's been fun."

Library advisory board chairman Mack Burtis reported that the Friends of the Library was officially started in May 1995. At last count there were about 80 Friends. In the strategic planning, modernization was a goal. By November 1995 the Friends of the Library formed a committee "Yes on 2A." Their first fundraising was a \$1.5 million bond issue to build the new library. It passed with a vote count of 1,008 to 998.

#### ORDINANCE NO. 1659

AN ORDINANCE TO AUTHORIZE THE IMPOSITION OF AN ADDITIONAL TAX OF ONE ALL SALES WITHIN THE CITY OF LA JUNTA; PROVIDING OTHER MATTERS AND RATIFYING ACTIONS PREVIOUSLY TAKEN RELATING THERETO

WHEREAS, the voters of the City of La Junta have determined that sales in La Junta should be taxed an additional one percent (1%) to help defray the costs of operation; and

WHEREAS, the citizens of La Junta have determined that the public interest and the needs of the City require that provision be made for the imposition of an additional one percent (1%) sales tax with the revenues generated therefrom to be used as provided herein; and

WHEREAS, the text of the ballot was as follows:

Shall City of La Junta's taxes be increased by approximately \$1,400,000.00 in 2023 and then annually by whatever additional amounts are raised thereafter by the imposition of additional 1% sales tax on all retail sales as defined in the Municipal Code of the City of La Junta within the City of La Junta beginning January 1, 2023 and continuing thereafter; with the net proceeds of such tax to be collected, retained and spent for the purposes of the City through its general fund; and shall the City be permitted to collect, retain and expend all revenue derived from such tax as a voter-approved revenue change and an exception to limits which would otherwise apply under Article X, Section 20 of the Colorado Constitution or any other law?

WHEREAS, a majority of the votes cast on the ballot issue submitted at the November 7, 2023 election were in favor of such question. As a result, the City (acting through the Council) is now authorized to proceed with all the necessary actions to impose an additional one percent (1%) sales tax in accordance with such question.

# BE IT THEREFORE ORDAINED BY THE CITY COUNCIL OF THE CITY OF LA JUNTA, COLORADO THAT;

- Section 3.04.020 is repealed in its entirety. SECTION 1.
- SECTION 2. Section 3.04.020 is re-enacted as follows:

## <u>Section 3.04.020</u> - Rate; imposition and collection; distribution.

- (a) Sales tax: Until December 31, 2023 at 11:59 p.m., there is hereby levied a tax or excise upon all sales of tangible personal property and services specified in Subsection 3.04.030(a). The rate levied shall be three percent (3%).
- (b) Sales tax: Commencing on January 1, 2024 and continuing thereafter, there is hereby levied a tax or excise upon all sales of tangible personal property and services specified in Subsection 3.04.030(a). The rate levied shall be four percent (4%).

#### SECTION 3. USE OF MONEY COLLECTED:

- (a) The City shall provide for the receipt and expenditure of revenues collected from the tax and the deposit of the same into a restricted fund as created by the Council to implement this ordinance.
- (b) Funds shall be used for the general operating purpose of the City.
